ITEM #2: Public Comments: Peggy Elias asked the Board if they were open to receiving corrections to SB 191. Ms. Elias shared that she held a conversation with Senator Daly regarding the bill and pointed out that it was not the intention of the Board to require legal videographers attend court reporting school and train the videographers to become court reporters. Senator Daly understood the different roles the court reporter and legal videographer held and was able to make the amendments for this open meeting. Senator Daly requested Peggy Elias attend the March 14, 2025 hearing to answer any questions the Senate Commerce and Labor may have relating to SB 191. No further comments.

ITEM #3: Approval of the Agenda:

ITEM #4: Consideration to Amend SB 191 – Revising Provisions Relating to Court Reporters and Court Reporting Firms: Kevin Diamond expressed his appreciation to Peggy Elias for her comments. Mr. Diamond shared that he has been in discussion with Senator Daly. Senator Daly submitted his language to LCB for drafting and forwarded LCB's draft to the Board. Upon reviewing LCB's draft, the Board felt there were areas that needed to be amended; not an uncommon practice when drafting language on a broad subject. Mr. Diamond reviewed each section and welcomed comments from the Board. Debbie Uehara read comments from William LaBorde who not present at the meeting. A copy of all changes and corrections made to SB 191 is attached and will be kept on file. Debbie Uehara will submit the amended language to Senator Daly after the meeting. No further comments.

MOTION by Kevin Diamond: That the Board approve Senator Daly's proposed amendments made to SB 191 with the changes made by the Board today, including section 2 from the original SB 191 language. Motion seconded by Linda Shaw, all in favor, motion moves forward.

ITEM #5: Public Comments: Kimberly Farkas reminded everyone that NVCRA will be hosting their 2025 Spring Seminar on March 29th and 30th at the Vegas Valley Winery. Peggy Elias encouraged the attendees to support NVCRA and support SB 191. No further comments.
